1 It is hereby adjudicated and declared that JUDGMENT is entered in favor of Plaintiff RB  
2 Capital Partners, Inc. as follows:

3 1. In the principal amount of \$11,500,000.00, plus \$3,119.583.70 in past due interest,  
4 plus \$1,786.80 in expenses and \$59,900.00 in attorneys' fees for a total JUDGMENT in the amount  
5 of \$14,681,270.50 against Defendants Roger Pawson and Optec International, Inc. jointly and  
6 severally;

7 2. Defendant Roger Pawson is hereby prohibited from serving as a director of Defendant  
8 Optec International, Inc.;

9 3. Defendant Roger Pawson is hereby prohibited from serving as a CEO of Defendant  
10 Optec International, Inc.;

11 4. Defendant Roger Pawson is prohibited from issuing any class stock of Defendant  
12 Optec International, Inc. or transferring any property of Defendant Optec International, Inc. to any  
13 himself or any third party;

14 5. Defendant Roger Pawson is prohibited from using Defendant Optec International  
15 Inc.'s assets for his personal gain and returning all ill-gotten funds back to Optec International, Inc.;

16 6. Upon application to the court by the Plaintiff, a receiver is to be appointed to control  
17 Defendant Optec International, Inc. and its assets.
